In order to obtain a Certificate of Good Conduct and for up to date information on any costs involved, you should contact the Embassy or High Commission of the country in question.

A translation will be required if it is not provided in English.

Failure to provide a certificate may prevent an application being considered. Failure to provide such information, without good reason, will be taken into account when a decision is made. Transport for London (TfL) will consider each individual case on its own merits, having regard to the need to protect the safety of the travelling public and whether the applicant has demonstrated that they are a 'fit and proper' person to hold a licence.
