**The Greater London (Central Zone) Congestion Charging (Variation)
Order 2013 Instrument of Confirmation 2014**

Coming into force

In accordance with Article 1

Whereas—

- (1) On 19 December 2013 Transport for London made The Greater London (Central Zone) Congestion Charging (Variation) Order 2013 (“the Variation Order”);
- (2) pursuant to paragraph 4(1)(b) of Schedule 23 to the Greater London Authority Act 1999(a) Transport for London submitted the Variation Order to the Mayor of London for confirmation; and
- (3) the Mayor of London has decided to confirm the Variation Order with modifications:

Now, therefore, the Mayor of London, in exercise of the powers conferred on him by paragraph 4(1)(b) of Schedule 23 to the Greater London Authority Act 1999, and of all other powers enabling him in that behalf, hereby makes the following Instrument:—

Citation and commencement

1.—(1) This Instrument may be cited as the Greater London (Central Zone) Congestion Charging (Variation) Order 2013 Instrument of Confirmation 2014 and shall come into force on the day on which it is made.

(2) In this Instrument “the Variation Scheme” means the Scheme contained in the Schedule to the Variation Order.

Confirmation of the Variation Order

2.—(1) The Variation Order is hereby confirmed subject to—

- (a) the modifications to the Variation Order set out in paragraphs (2) to (5) below; and
- (b) the modification of the Variation Scheme set out in the Schedule to this Instrument.
 - (2) In article 1(2) of the Variation Order before “and 8(1)” there shall be inserted “, 6”.
 - (3) In article 1(3) of the Variation Order “6,” shall be omitted.
 - (4) In article 2(1) of the Variation Order for “Principle” there shall be substituted “Principal”.
 - (5) In article 2(3) of the Variation Order before “and 8(1)” there shall be inserted “, 6”.

SCHEDULE TO THE INSTRUMENT

Article 2(1)(b)

Vehicles used by certain NHS employees and for transporting certain NHS patients

1. For article 8 of the Variation Scheme there shall be substituted—
- “8. —(1) In paragraph 8(1)(a) and 9(1)(a) of Annex 2 “other than by CC Auto Pay” shall be omitted.
(2) For paragraph 8(4)(e)(i) there shall be substituted—
 “(i) a general medical services contractor who is a party to a general medical services agreement within the meaning of the National Health Service (General Medical Services Contracts) Regulations 2004**(b)**”;
(3) In paragraph 8(4)(e)(iii) of Annex 2 for “2004” and for the footnote to that reference there shall be substituted “2013**(d)**”.
(4) For paragraph 8(4)(e)(iv) there shall be substituted—
 “(iv) a NHS Trust who provides primary medical services pursuant to section 92 of the National Health Service Act 2006**(e)**”;
(5) In paragraph 8(4)(f) of Annex 2 for “Primary Care Trust” there shall be substituted “NHS Commissioning Board, Clinical Commissioning Group”.
(6) In paragraph 9(1)(b) of Annex 2 “primary care trust,” shall be omitted.”
