

## English Cricket Board competition

### Terms and conditions

The Competition begins on Wednesday 17 July 2024 at 9am (“the Opening Date”) and ends on Monday 22 July 2024 at 12pm (“the Closing Date”). Entries to the Competition must be submitted before the Closing Date.

In order to enter, you must submit a comment on the competition post and complete all entry requirements. It must be your original work.
