

## **70 years of Routemaster competition**

### Terms and conditions

The Competition begins on Tuesday 24 September 2024 at 10:00 am (“the Opening Date”) and ends on Monday 30 September 2024 at 12:30pm (“the Closing Date”). Entries to the Competition must be submitted before the Closing Date.

In order to enter, you must follow Transport for London and London Transport Museum on Instagram and submit a comment on the competition post. It must be your original work.
