Terms and conditions

The Competition begins on Friday 06 January 2023 at 09:00am (“the Opening Date”) and ends on Friday 13 January 2023 at 12:00pm (“the Closing Date”). Entries to the Competition must be submitted before the Closing Date.

In order to enter you must follow @transportforlondon on Instagram, tag a friend in the comments of the competition post, telling us why you’d go cycling with them, and share the competition post to stories. It must be your original work.
