The Competition begins on Friday 14 April at 09:00am (“the Opening Date”) and ends on Friday 21 April at 12:00pm (“the Closing Date”). Entries to the Competition must be submitted before the Closing Date.

In order to enter you must follow Transport for London on Instagram, like the competition post, tag a friend in the comments, and comment your favourite London memory. It must be your original work.
