## London Taxi or Private Hire Vehicle (PHV) Driver's Licence Living Abroad Details Form

If you have lived in a country other than the UK for one or more continuous periods of 3 months or more within the last 10 years, as an adult (aged 18 years or older), please provide the following information in the section(s) on this form:

- The date that the period of living abroad began and ended
- The name of the country where you have lived
- The full address (in as full a format as possible) where you were living
- Details of any convictions gained as a result of offences committed during this period

If you have lived abroad **for more than one** continuous period of 3 months or more within the last 10 years, and/or you have lived in **multiple countries/locations** for **any** continuous period of 3 months or more within the last 10 years, please photocopy this form and complete a form for each one. Please remember to submit all completed forms to us.

**PLEASE NOTE:** If you have lived in a country other than the UK for one or more periods of three months or more in the last 10 years, as an adult (aged 18 years or older), **you will be required to produce** a Certificate of Good Conduct issued by the relevant non-UK country.

A 'Certificate of Good Conduct' is an extract from the judicial record or an equivalent document issued by a competent judicial or administrative authority in the relevant country.

In order to obtain a Certificate of Good Conduct and for up to date information on any costs involved, you should contact the Embassy of High Commission of the country in question.


The Certificate of Good Conduct will **need to be stamped/endorsed** by the relevant Embassy.

### A translation will be required by an official interpreter, if it is not provided in English.

You will also be required to provide **an apostille** for **any** Certificate of Good Conduct that has been obtained. An apostille is a document, stamp or seal which legalizes the document it is attached to for international use. The apostille **must be** obtained **in the same country** in which the original Certificate of Good Conduct was issued.

Failure to provide a Certificate of Good Conduct may prevent an application being considered. Failure to provide such information, without good reason, will be taken into account when a decision is made. Transport for London (TfL) will consider each individual case on its own merits, having regard to the need to protect the safety of the travelling public and whether the applicant has demonstrated that they are a 'fit and proper' person to hold a licence.

Where you are aware that you have committed any offence overseas, you are advised to seek independent expert or legal advice to ensure that any information provided is truthful and accurate.
